STATEMENT OF PRINCIPLES OF ZIONISM

AS ADOPTED BY THE AZM NATIONAL BOARD JUNE 4, 2018

The American Zionist Movement (AZM), comprising 28 national Jewish Zionist organizations, links the diverse American Jewish community in support of Israel, Zionism and the Jewish People. The AZM and its constituent organizations represent American Zionists within the National Institutions of Israel, including the World Zionist Organization (WZO). The AZM and its constituent organizations fully support and endorse The Jerusalem Program of the WZO, the global statement of the beliefs of the Zionist movement.¹

The American Zionist Movement (AZM), through action and deed, supports these principles:

- The sovereign state of Israel's unconditional right to exist as the Jewish democratic homeland;
- The right of the people of Israel to live in peace and security;
- Pride in the common history, culture, destiny and religious heritage of the Jewish people;
- Pride in Israel's rich contributions to the world and its aspirational role to be an exemplary society for all of humanity; and
- Israel's centrality to Jewish identity and life.

Zionism Forward is the AZM's campaign to:

- Strengthen support for Israel, the Jewish people and Zionism.
- · Celebrate the ideology and cause of Zionism.
- Help strengthen Israel's position in the global family of nations.
- Improve the dialogue on Zionism in America and participate in a new effort to guide the American Jewish people to speak in a unified and informed voice in support of Zionism's core principles.
- Provide the forum that fosters our diverse constituent Zionist organizations' respectful coalescence around our commonality.

Zionism, the national liberation movement of the Jewish people, brought about the establishment of the State of Israel, and views a Jewish, Zionist, democratic and secure State of Israel to be the expression of the common responsibility of the Jewish people for its continuity and future. The foundations of Zionism are:

- The unity of the Jewish people, its bond to its historic homeland Eretz Yisrael, and the centrality of the State of Israel and Jerusalem, its capital, in the life of the nation;
- Aliyah to Israel from all countries and the effective integration of all immigrants into Israeli society.
- Strengthening Israel as a Jewish, Zionist and democratic state and shaping it as an exemplary society with a unique moral and spiritual character, marked by mutual respect for the multi-faceted Jewish people, rooted in the vision of the prophets, striving for peace and contributing to the betterment of the world.
- Ensuring the future and the distinctiveness of the Jewish people by furthering Jewish, Hebrew and Zionist education, fostering spiritual and cultural values and teaching Hebrew as the national language;
- Nurturing mutual Jewish responsibility, defending the rights of Jews as individuals and as a nation, representing the national Zionist interests of the Jewish people, and struggling against all manifestations of anti-Semitism;
- Settling the country as an expression of practical Zionism.

OR ADIEast Coast Director, WZO Department For Diaspora Activitiesn

Or Adi is the new East Coast Director of the Department for Diaspora Activities (DDA) of the World Zionist Organization. She is 29 years old and has a BA in International Relations and Middle Eastern Studies from the Hebrew University of Jerusalem and speaks Hebrew, English, Spanish and Arabic. The DDA works primarily to introduce Jews in the Diaspora to different aspects of Israeli culture, politics, and society through quality educational content and programming. Or's main goals within her work is to encourage young Jews all over the East Coast to continue and strengthen the relevance and importance of Zionism in their everyday lives.



ALON BEN-GURION

Former IDF Paratrooper and Grandson of Israeli Prime Minister David Ben-Gurion

Alon Ben-Gurion was born in Israel in 1951. He grew up in Tel Aviv and Haifa, where he attended high school and participated in the youth movement. At the age of 18, he joined the IDF and became a paratrooper. Alon was severely wounded in the Yom Kippur war and spent the next several months hospitalized, and then in rehabilitation. After a long recovery, Alon attended Tel Aviv University and received his BA degree, followed by a Master's Degree from Cornell University in the area of Hospitality Management. For the last 40 years years Alon has worked in the hotel management field in various countries that include Israel, England, Belgium and the United States. He had the privilege of working at very prestigious hotels such as the Tel Aviv and Jerusalem Hiltons, the Park Lane Hilton in London, the Capital Hilton in Washington, and managed the famous Waldorf Astoria, New York.

In addition to his work, Alon was traveling on behalf of various organizations, speaking about the legacy of his grandfather, David Ben-Gurion. Alon was also involved with organizations such as The Friends of the Disabled Veterans of the IDF, JNF USA, Israel Bond, Jewish Federation and Ben Gurion University Currently Alon is assisting American disabled veterans via the Heroes to Heroes organization.

He is married to Anastasia, a fashion designer and Associate Professor at the Fashion Institute of Technology. They have two daughters, Alexandra and Daphne. Alon is the son of Amos and Mary Ben-Gurion and the grandson of the late Prime Minister, David Ben – Gurion.



LIOR BEN-ZVI

Educational Coordinator. Hashomer Hatzairr

Lior Ben-Zvi has been a staff member at Camp Shomria (af. Hashomer Hatzair USA) for six years, and in that time has worked everything from bunk counselor to maintenance crew. Additionally, she has led the oldest age group (CITs) in a month long intensive learning trip to Israel, and most recently served as Educational Coordinator, who oversees educational programming by all the counselors. After high school, Lior did a shnat sherut in Israel through Hashomer Hatzair, volunteering in a regional kibbutz school and organizing after school programming for some kibbutzim. She is currently a student at Rutgers University majoring in French and Middle Eastern Studies.



MEREDITH BERKMAN

Founder, The Zionista Project

Meredith Berkman is the founder of The Zionista Project, a philanthropic effort that seeks to "rebrand" Zionism and make it cool for the next generation. Donating trademarked "Zionista" swag (including tees, totes, and baseball caps) to Israel-supporting groups at colleges and universities around the country, the Zionista Project promotes a nonpolitical way to publicly express a love of Israel, asking in return that students post photos and tag the project on social media. She is also a co-founder of Parents Against Vaping E-cigarettes, a grassroots advocacy group dedicated to protecting kids from flavored e-cigarettes like JUUL. A former journalist, she is a graduate of Brown University, where she is a longtime Hillel board member, and the Columbia University Graduate School of Journalism. She blogs weekly about Torah at shabbatmom.com. She and her husband have four kids and live in Manhattan.



NOA BLOCH

Chair of Public Affairs, Zionist Federation of Australia

Noa Bloch is the Chair of Public Affairs for the Zionist Federation of Australia (ZFA). A recent graduate of a double degree in Law and Econometrics from Monash University, Noa is currently interning at the World Jewish Congress in New York before commencing work as a consultant at Boston Consulting Group. Noa previously worked for politicians in both Australia and the US and before joining the ZFA, was involved in Jewish community advocacy at the student-level.



HERBERT BLOCK

Executive Director, American Zionist Movement

Herbert Block has been Executive Director of the American Zionist Movement since March 2017. Since 2011 he has also been a Presidential Appointee as a Member of the U.S. Commission for the Preservation of America's Heritage Abroad. From 1999 until 2015 Mr. Block was an Assistant Executive Vice-President of the American Jewish Joint Distribution Committee. Previously, he served as Assistant Director for Intergovernmental and Public Affairs for the New York City Independent Budget Office from 1996 to 1999, and was Deputy Director for Intergovernmental Relations at the Corporation for National and Community Service from 1994 to 1995. Mr. Block was Assistant to the Mayor of the City of New York from 1990 to 1993 and a Special Assistant to the Manhattan Borough President from 1986 to 1989. He is the NYC Mayor's appointee to the Board of Directors of the Museum of Jewish Heritage—A Living Memorial to the Holocaust. Mr. Block serves on the board of several other non-profit organizations in NYC and on Holocaustera property restitution bodies in Poland and Lithuania. Mr. Block received a B.A. from Columbia University and a J.D. from Brooklyn Law School.



RACHAEL BRILL

Associate Director of Camping, Union for Reform Judaism

Rachael Brill is the Associate Director of Camping for the Union for Reform Judaism (URJ), overseeing the ongoing operations of the URJ's 17 summer camps that serve over 10,000 children across North America a year. Rachael has been at the URJ for over six years, previously as a senior program manager spearheading two fellowships focused on global Reform Jewish leadership, and as a human resources associate. Prior to coming to the URJ, Rachael was the U.S. Manager of Marketing and Community Outreach at the Nesiya Institute, a six-week Jewish teen summer program in Israel aimed at fostering a deeper and more meaningful connection to the land and people of Israel. Rachael grew up in Massachusetts and received her BA in Political Science from Tufts University. She currently lives in Brooklyn, New York and is an avid sailor, rock climber, and dog lover.

HONORABLE ELAN S. CARR

US Special Envoy to Monitor and Combat Anti-Semitism

Elan S. Carr serves as the Special Envoy to Monitor and Combat Anti-Semitism. As Special Envoy, he advises the Secretary of State and is responsible for directing U.S. policies and projects aimed at countering anti-Semitism throughout the world.

Prior to his appointment, Special Envoy Carr served as a Deputy District Attorney for Los Angeles County, where he prosecuted violent crimes for more than a decade, including murders, rapes, hate crimes, and crimes involving some of the most notorious criminal street gangs in Southern California.

Special Envoy Carr is an officer in the United States Army Reserve, and he has received multiple awards and commendations for his nearly two decades of military service. In 2003-04, he deployed to Iraq in support of Operation Iraqi Freedom, where he led an antiterrorism team in life-saving missions throughout the country and prosecuted terrorists who attacked U.S. troops. He also assisted efforts to establish an independent Iraqi judiciary and trained Iraqi judges and lawyers on constitutional law and criminal defense.

As the son of Iraqi Jewish refugees who fled persecution in Iraq, Special Envoy Carr speaks Hebrew and the Iraqi dialect of Arabic. While in Iraq, he met with remnants of the Jewish community there and led Jewish services in the former presidential palace of Saddam Hussein in Baghdad.

Special Envoy Carr was the international president of the Jewish fraternity Alpha Epsilon Pi, he served on the National Council of the American Israel Public Affairs Committee (AIPAC), he was a voting member of the Conference of Presidents of Major American Jewish Organizations, and he was a board member of Operation Gratitude. In the course of his work in the Jewish community, he has been a recognized leader in the fight against anti-Semitism on U.S. college campuses and around the world.

AMBASSADOR DANI DAYAN

Consul General of Israel in New York

As Consul General of Israel in New York Consul General, Dani Dayan represents the State of Israel to communities from throughout New York, New Jersey, Pennsylvania, Ohio and Delaware. Nominated to this post by Prime Minister Benjamin Netanyahu, Amb. Dayan enjoys wide support and appreciation from all sides of the Israeli political spectrum. He has a long time reputation as an Israeli public figure, lecturer and entrepreneur. Dayan was Chairman of the Council of Jewish Communities in Judea and Samaria from July 2007 until January 2013. He was instrumental in pushing through multiple reforms and policy changes to strengthen the image of the organization and advocate on behalf of its 400,000 citizens. After serving in the elite MAMRAM computerized data processing center of the Israel Defense Forces, Dani Dayan began his professional career as a businessman, at the young age of 26, founding Elad Systems which specializes in sophisticated information systems, outsourcing, and facility management. In 2005, when Dayan sold his interests in the firm, it employed 500 IT professionals. Born in Buenos Aires, Argentina in 1955, Dayan immigrated to Israel in 1971. He holds a B.Sc. in Economics and Computer Sciences from Bar Ilan University and M.Sc. in Finance from Tel Aviv University. He resides with his wife and daughter in the community of Maale Shomron in central Samaria.



AVRAHAM 'DUVDEV' DUVDAVANI

Chair, World Zionist Organization

Before joining the WZO in 1991, he served as Secretary General of World Bnei Akiva and headed the Department of Informal Education at Orot Israel College. He also spent a decade at The Jewish Agency, directing various educational programs and spent three years in Europe on behalf of The Jewish Agency. RABBI ANDREW ERGAS

Chair, Council for Hebrew Language and Culture in North America

Bringing over twenty-five years of involvement in Jewish education and organizational leadership, Rabbi Andrew Ergas is the Executive Director of the Harold and Elaine Shames JCC on the Hudson, previously serving in a similar role at the Jewish Community Project Downtown (JCP), a new model of Jewish community based in Tribeca that integrates a school, non-denominational congregation and communal center. Prior to JCP, Andrew spent seven years as Head of School at Beit Rabban Day School on Manhattan's Upper West Side. In the past, his roles included Executive Director of the Association of Reform Zionists of America (ARZA), a Director of the Union for Reform Judaism's Youth Division, a resident and day camp director for both Young Judaea and for JCC's, and as an organizational management consultant. Andrew was ordained in Jerusalem by the Hebrew Union College – Jewish Institute of Religion and holds master's degrees in nonprofit management and in Hebrew literature. A graduate of the Harvard Graduate School of Education certificate program, Andrew is also a doctoral candidate in education at the Jewish Theological Seminary, with a research focus on Hebrew, identity and pedagogy. A frequent lecturer and writer on Israel and Diaspora relations, Jewish history and effective change management within organizational life, Rabbi Ergas is recognized as a leading speaker and educator in the Jewish community and beyond. A founding member of the Hebrew Council, Rabbi Ergas was elected to the position of Chair in November of 2016.

Amitai Fraiman is the Director of Z₃, OF JCC's annual Zionism conference. In this role, he oversees the conceptualization and execution of the local conference as well as supports the expansion of the Z₃ model to other JCC's around the country and developing other avenues for Z₃ activities and partnerships. Amitai is the founder of /Interwoven, an educational start-up aimed at bridging the growing gap between Israel and American Jewry. Amitai received rabbinic ordination from YCT Rabbinical School as well as a dual MPA-MA from NYU. Born and raised in Israel, Amitai currently lives with his family in NY.



RABBI DAVID GEDZELMAN

President & CEO, Steinhardt Foundation for Jewish Life

Rabbi David Gedzelman is President & CEO of The Steinhardt Foundation for Jewish Life, which is dedicated to revitalizing Jewish identity through educational and cultural initiatives as well as to advocating for and supporting Hebrew and Jewish literacy among the general population. David has been actively involved in the Foundation's programs since 1995, when he was recruited to conceive and develop Makor in New York City. As the Founding Creative and Rabbinic Director of Makor, David created and led a cutting-edge venue for New Yorkers in their 20s and 30s, providing innovative arts, cultural and educational programming aimed at engaging an under-involved population in possibilities of Jewish life and meaning.

Rabbi Gedzelman was the lead professional at the Foundation working on the conceptualization, design, and implementation of Hebrew language public charter schools, which the Foundation has played a founding role in supporting since 2007. Rabbi Gedzelman's passion for the Hebrew language and his deep commitment to inter-group understanding as well as supporting integrated and diverse public schools suited him well for this project which now encompasses a network of twelve schools nationwide overseen by Hebrew Public: Charter Schools for Global Citizens, a grantee of the Foundation. David has been a champion of Hebrew fluency and literacy in North America and is a founding member of the World Zionist Organizations Council on Hebrew Language and Culture in North America.

Rabbi Gedzelman holds a B.A. from Hamilton College, an M.A. from Duke University in Comparative Religion, and Rabbinical Ordination from the Reconstructionist Rabbinical College. He has studied in Israel at the Hebrew University and at the Pardes Institute. He serves on the Boards of The American Pardes Foundation, One Table: Shabbat Together, The Harlem Minyan, and 70 Faces Media. Rabbi Paul Golomb is the Senior Scholar and Rabbi Emeritus of The Vassar Temple in Poughkeepsie, NY, after serving as their rabbi for fifteen years. A graduate of Hebrew Union College-Jewish Institute of Religion, he has been a Director of Hillel Foundations, the URJ Regional Director for Canada, as well as a congregational rabbi. Rabbi Golomb has taught undergraduate and graduate courses in philosophy, classical and modern Jewish thought. In 2018 he completed service as the Editor-in-Chief of the CCAR Journal: A Reform Jewish Quarterly, and has published articles on biblical studies, modern Jewish thought, interfaith relations and Reform Zionism. He is the principal investigator of a longitudinal study of Birthright Israel, a large-scale educational program. At the Steinhardt Institute, he is leading a program that is investigating the size and characteristics of the American Jewish population. Among his recent publications, he is co-author of a 2008 book, Ten Days of Birthright Israel: A Journey in Young Adult Identity, the story of Birthright Israel, an intensive ten-day educational program designed to connect Jewish young adults to their heritage. Professor Saxe is an author and/or editor of nearly 250 publications. He has been a Science Fellow for the United States Congress and was a Fulbright Professor at Haifa University, Israel. In 1989, he was awarded the American Psychological Association's prize for Distinguished Contributions to Psychology in the Public Interest, Early Career.



RABBI ARTHUR SCHNEIER

Park East Synagogue and Day School & former leader of Midstream Magazine & the Theodor Herzl Foundation

Rabbi Arthur Schneier is internationally known for his leadership on behalf of religious freedom, human rights and tolerance, whose activities have spanned the globe for more than four decades. He has played a major role in addressing issues in the former Soviet Union and Russia, China, Central Europe, Latin America and the Balkans.

As founder and President of the Appeal of Conscience Foundation (1965) and a spiritual leader of New York's Park East Synagogue (1962), he was awarded the Presidential Citizens Medal for "his service as an international envoy for four administrations" and "as a Holocaust survivor, devoting a lifetime to overcoming forces of hatred and intolerance."

Recipient of U.S. Department of State Special Recognition Award for "...his ecumenical work in favor of mutual understanding, tolerance and peace...."

Since 1962, Rabbi Arthur Schneier has been the Senior Rabbi of the 125-year old Park East Synagogue, one of New York City's historic landmark houses of worship and home to one of the leading modern Orthodox congregations in the U.S. and founder of the Rabbi Arthur Schneier Day School. He has received many world leaders at Park East, including two Secretaries General of the U.N. In 2008, he was host to Pope Benedict XVI, the first ever Papal visit to a synagogue in the U.S. and in 2009 welcomed the Ecumenical Patriarch Bartholomew I.



Anat Schwartz, a mother of 3 boys, has been working as an El Al flight attendant for 15 years. Anat is an accomplished actor who was nominated for best actress at the 2001 Israeli Oscars. She had a starring role in the Israeli film "6 million Pieces", and is the granddaughter of Holocaust survivors. Anat is also an accomplished artist and singer songwriter and starred in an El Al commercial.



DR. ESTHER SEROK

Representative of the World Zionist Organization Executive in North America

Esther Serok EdD, is the incoming Representative of the WZO Executive in North America and has over 40 years of experience in education, family education, teacher training, and staff and curriculum development in multi-cultural settings. Esther teaches at the Hebrew University in Jerusalem, and is a senior researcher at the NCJW Research Institute at HU. A Hebrew University graduate and certified high school teacher. She holds a doctorate in Jewish Education from JTS.



DR. FRANCINE STEIN

Chair of the National Board, American Zionist Movement Past National President, AMIT

Dr. Francine S. Stein has served as the chair of programming and sits on the Cabinet and Board of the AZM. Francine is also a Past National President of AMIT. She also represents AMIT/World Mizrachi as a committee member of the Jewish Agency Board of Governors. Dr. Stein is a pediatrician specializing in behavioral/developmental pediatrics currently in private practice in Englewood. She attended New York Medical College in Valhalla, New York, where she received her M.D. degree. Francine is married to Dr. Aaron Stein, a cardiologist. They are the parents of three children. MINDY STEIN

Biennial Co-Chair, American Zionist Movement Honorary National President and Chairman of The Board, Emunah of America

Mindy Stein was born in Toronto, Canada. She is the Former National President and Chairman of the Board of Emunah of America, which supports 250 social service and educational institutions in Israel. And she is the founder of BeCounted4Israel- a grass roots initiative encouraging advocacy on behalf of Israel. Currently she works as a Speech Pathologist and Audiologist at Montefiore and Misericordia Hospitals. Mindy used to own and run a Children's clothing Business. She has a Bachelor of Science from the University of Toronto and a Masters in Speech Pathology and Audiology New York University.



PROFESSOR GIL TROY

Historian and Author

A Distinguished Scholar in North American History at McGill University currently living in Jerusalem, Gil Troy is an award-winning American presidential historian and a leading Zionist activist. In the Foreword to Troy's latest book, The Zionist Ideas: Visions for the Jewish Homeland – Then, Now, Tomorrow, Natan Sharansky writes: "This magnificent work is the perfect follow-up to Arthur Hertzberg's classic The Zionist Idea. Combining, like Hertzberg, a scholar's eye and an activist's ear, Gil Troy demonstrates that we now live in a world of Zionist Ideas, with many different ways to help Israel flourish as a democratic Jewish state."

Recently designated an Algemeiner J-100, one of the top 100 people "positively influencing Jewish life," Troy wrote The Age of Clinton: America in the 1990s, and ten other books on the American presidency. One leading historian called Age of Clinton "the best book on the man and his times." Troy edited and updated another classic, the multi-volume History of American Presidential Campaigns, originally edited by Arthur M. Schlesinger, Jr. and Fred Israel. He is now writing new essays on the 2012 and 2016 elections.

Troy's book Moynihan's Moment: America's Fight against Zionism as Racism, describes the fall of the UN, the rise of Reagan and the spread of Anti-Zionism. Jewish Ideas Daily designated it one of 2012's "best books."

He appeared as a featured commentator on CNN's popular multipart documentaries, The Eighties, The Nineties, and The 2000s. He has been interviewed on most major North American TV and Radio networks. Troy has published essays in the American, Canadian, and Israeli media, including writing essays for the New York Times' "Campaign Stops" in 2012 and 2016. He wrote a weekly column for the Daily Beast, "Secret Lives," putting current events in historical perspective, and writes a weekly column for the Jerusalem Post.



RABBI JOSHUA WEINBERG

President of ARZA, the Association of Reform Zionists of America

Rabbi Josh Weinberg has been President of ARZA since 2013. After receiving his B.A. from the University of Wisconsin, engaging in the NFTY-EIE program, and studying at the Hebrew University Rabbi Weinberg came to Israel on Aliyah in 2003, He began teaching as a Jewish History faculty member on the EIE program. He subsequently served in the IDF Spokesperson's unit and studied for an M.A. at the Hebrew University in Jewish Education. He was ordained from the HUC-JIR Israeli Rabbinic Program in Jerusalem and is currently living in New York. Rabbi Weinberg previously served as the Director of the Israel program for the Reconstructionist Rabbinical College. He currently serves as a mentor for the iCenter's iFellows mentoring program. Josh is also a reserve officer in the IDF spokesperson's unit, and has hiked the Israel-trail. He is married to Mara Sheftel Getz, and they have four daughters: Noa, Ella, Mia, and Alma.



ROEY YAMINS


Head of the North America Delegation, WZO Department for Diaspora Activities

Roey Yamin is Head of the DDA-WZO Delegation to North America. He believes in the great contribution of the social sector to Israeli society, Roey was a proud part of the executive leadership of the Nalaga'at Cultural Center of artists with disabilities and a senior member of IGY-the LGBT youth movement. His passion for innovative platforms for social dialogue led him to co-found several initiatives such as: Israel's first art festival of deaf and blind artists and dialogue for youths from diverse backgrounds.

Roey's first encounter with the Jewish diaspora took place as a Shaliach to Stanford University, and in his current position the wishes to connect Jews to Israel by introducing them to its innovative and rebellious society. He earned a B.A. in communication & Political Science from Tel Aviv University a Journalist Certificate from Koteret School for Media and a M.B.A in the prestigious Mandel Society Leadership Program at Ben Gurion University.

SEYMOUR D. REICH

1993-1997



Mr. Reich has been a fervent supporter of Middle East peace as well as a strong advocate of human rights causes. In his capacity as chairman of the COP, he served as chief spokesman of the world's largest Jewish community in its relations with the White House, the United Nations, the Sate of Israel and other governments around the world. After concluding his tenure, Mr. Reich was named chairman of the National Task Force on Syrian Jewry, where he was deeply involved in the reserve of 4,000 Syrian Jews.

In his recent position as chairman of the IJCIC, he urged the Vatican to open the World War II archives. Subsequently, he served as a coordinator of the International Catholic-Jewish Historical Commission, a panel of scholars from both faiths created by the Vatican and major Jewish organizations to study the role of the Vatican during the Holocaust period. Mr. Reich was also in the forefront of the campaign to secure freedom of emigration for Soviet Jews.

Mr. Reich has met with U.S. Presidents, with Prime Ministers of Israel and with key Cabinet members and leaders of opposition parties in the Jewish State, as well as with the top leaders of foreign governments. In 1987, he was one of nine world Jewish leaders involved to the Vatican for an unprecedented meeting with Pope John Paul II on Catholic-Jewish relations. In 1990 he led a delegation of Jewish leaders to Rome for a historic meeting with the Pope, and has more recently met with Pope Benedict XVI.

Reich was one of the first Jewish leaders to publicly support the release of Jonathan Pollard on humanitarian ground. In 1993, together with Elie Wiesel, he visited Jonathan when he was in solitary confinement in the Marion penitentiary.

A Phi Beta Kappa graduate of the University of Pennsylvania, Mr. Reich received his law degree from Harvard. He was awarded an honorary degree by Tel Aviv University. He lives in Manhattan. Mr. Reich has three grown children, Leslie, Jamie and Keith.

MELVIN SALBERG (Z"L)

1997-2002

Melvin Salberg was a leader in American Jewish organizations, serving as national chairman the Anti Defamation League from 1990 to 1994 and chairman of the Conference of Presidents of Major Jewish Organizations from 1997 through 1999. In these roles, he was closely involved in Middle East peace negotiations at the request of President Bush and President Clinton. In his professional career, Mr. Salberg served as management's chief spokesman and strategy advisor in union-management collective bargaining in numerous industries, including paper and pulp, cement, electronics, publishing, communications, garment and other manufacturing and service industries, as well as not-for-profit institutions. He assisted employers in the full spectrum of labor issues, such as plant opening and closing, relocation, reduction in force and introduction of technical change. He had particular experience in counseling management in planning and implementing participative labor-management cooperation programs. Mr. Salberg served with United States Maritime Service during World War II from 1943 to 1945. He earned a B.A. at New York University in 1949 and a J.D. at NYU School of Law in 1951. He married Rita Cecile Kahn in 1948, who passed away in 1985. He is survived by his second wife, Anita Marie Gessler, whom he married in 1987, and by his children, Michael, Robert, Barbara, and Lawrence.

Reich scholarships are awarded each fall and spring to a limited number of American students who choose to study at one of several designated Israeli universities or attend post-college long-term programs. The purpose of the scholarship is to encourage young American Jews to become more involved with and knowledgeable about Israel. It was intended to award those who have already demonstrated Zionist involvement and activity, or, alternatively, to help those seeking to learn more about their connection to Israel and who express an intent toward greater involvement in the Jewish community.
