### CERTIFICATE OF AMENDMENT

1. The name of the corporation is AMERICAN ZIONIST FEDERATION, INC.

2. The original certificate of incorporation was filed with the Department of State of the State of New York, on March 26, 1970 and the said corporation was formed under the then existing Membership Corporations Law (now the Not-for-Profit Corporation Law) of the State of New York.

3. The corporation is a corporation as defined in subparagraph (a)(5) of section 102 (Definitions). The corporation is a Type B corporation under Section 201(b)

4. The proposal to amend the Constitution and By-Laws was & duly transmitted to the members in accordance with the said Constitution and By-Laws, and was approved at a meeting of the membership held on January 31st, 1993, at which a quorum was present, whereat said amendments were approved unanimously.

5. Article First of the Certificate of Incorporation is amended read as follows: "FIRST: The name of the Corporation is AMERICAN ZIONIST MOVEMENT, INC."

6. The voting rights of all members are to remain the same except that as to those members suspended for being delinquent in payment of dues, said suspended members shall have no voting rights unless and until restored to membership.

7. The Secretary of State of the State of New York is designated as agent of the corporation upon-whom process against it may be served and the post office address within the State to which the Secretary of State shall mail a copy of any process against it served upon the said Secretary of State is: AMERICAN ZIONIST MOVEMENT, INC., 110 East 59th Street (third floor)) New York, New York 10022. #### CERTIFICATE OF INCORPORATION

-of-

AMERICAN ZIONIST FEDERATION, INC.

(Pursuant to the Membership Corporations Law)

WE, the undersigned, for the purpose of forming a membership corporation, pursuant to the Membership Corporations Law of the State of New York, do hereby certify:

FIRST: The name of the proposed corporation shall be AMERICAN ZIONIST FEDERATION, INC.

SECOND: The purposes for which it is formed are:

(a) 1. To motivate American Jews to accept the Zionist principles that the Jews the world over are one people, united by a common history, heritage, and destiny, with Israel as the center of Jewish life everywhere;

2. To foster Zionist and Jewish ideals among Jews in the United States and engage in activities on behalf of the Zionist Movement in the United States, within such limitations as are provided by law;

3. To interpret the history, social and cultural life, achievements and problems of American Jewry and Zionism to Jewish communities throughout the world;

4. To collect and disseminate such information as may help safeguard the Jewish homeland and protect Jewish rights everywhere; 5. To cooperate with agencies assisting Jews who need or want to settle in Israel;

6. To encourage the development of institutions and data for education in Judaism, Hebrew and the culture of the Jewish people;

7. To promote research, study and discussion of Zionist ideas and aims;

8. To foster and support programs which will involve American Jewish youth in Zionist activities, and to encourage their participation in the work of the organization nationally and locally;

9. To further the efforts of the United Jewish Appeal, the United Israel Appeal, the Jewish National Fund, Jewish welfare funds and federations, and other fund-raising agencies supporting Jewish education and youth programs and advancing Jewish welfare.

(b) As a means of accomplishing the foregoing purposes, the Corporation shall have the following powers:

- To appeal for, accept and receive, from any person, firm, corporation, society or association, welfare or community fund, contributions, pledges or donations of money, securities, subscriptions, gifts, legacies, bequests, and property in any other form, whether personal property or real property, or mixed, and wherever the same may be situated.
- To hold, administer, sell, exchange, convey, mortgage, lease, transfer, or otherwise dispose of, any such property, both real and

personal, as the objects and purposes of the corporation may require, subject to such limitations as may be prescribed by law.

3. To borrow money, and, from time to time, to make, accept, endorse, execute, and issue bonds, debentures, promissory notes, bills of exchange, and other obligations of the corporation for moneys borrowed or in payment for property acquired or for any of the other purposes of the corporation, and to secure the payment of any such obligations by mortgage, pledge, deed, indenture, agreement, or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property, rights or privileges of the corporation wherever situated, whether now owned or hereafter to be acquired.

- 4. To invest and reinvest its funds in such stock common or preferred, bonds, debentures, mortgages, or in such other securities and property as its Board of Directors shall deem advisable, subject to the limitations and conditions contained in any bequest, devise, grant, or gift, provided such limitations and conditions are not in conflict with the provisions of Section 501 (c) (3) of the Internal Revenue Code and its Regulations, as they now exist or as they may hereafter be amended.
- 5. To establish branches, committees, groups and associations affiliated with the corporation, in all the states, territories and possessions of the United States, and other countries, for the purpose of carrying out the objects of the corporation, as aforesaid.
- 6. In general, and subject to such limitations and conditions as are or may be prescribed by law, to exercise such other powers which now or hereafter may be conferred by law upon a corporation organized for the purposes hereinabove set forth, or necessary or incidental to the powers so conferred, or conducive to the attainment of the purposes of the corporation subject to the further limitation and condition

that only such powers shall be exercised as are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

(c) No part of the net earnings of the corporation shall inure to the benefit of any member, director, trustee, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, director, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

(d) Upon the dissolution of the Corporation or of the winding up of its affairs, the assets of the Corporation shall be distributed solely to religious, charitable or educational organizations which would then qualify under the provisions of Section 501(c) (3) of the Internal Revenue Code of 1954 as they then existed or as they may hereafter be amended, subject to the approval of the Supreme Court of the State of New York.

(e) Nothing herein contained shall authorize the doing of any act which would require the approval of any department of the State of New York or the doing of any act mentioned in Membership Corporations Law Sec. 11 or Social Welfare Law Sec. 35.

THIRD: The territories in which the operations of the Corporation are principally to be conducted are the United States of America and its territories, dependencies and possessions; the Dominion of Canada and other countries in the Western Hemisphere, and countries in other parts of the world.

FOURTH: The city and county in which the office of the Corporation is to be located are the City of New York, County of New York.

FIFTH: The number of directors of the Corporation will not be less than three (3) nor more than three hundred (300).
